Also on the 15<sup>th</sup> of August, 2009, Sgt. R. FLINDALL received an email from court officer John HOBBINS dated the 12<sup>th</sup> of August, through Sgt. T. BANBURY. PC J. HOBBINS outlines a conversation he had with an upset court clerk (unnamed at her request) who advised that PC JACK had attended her residence looking for a male party.
