Mr. Jack has been a patient in my Clinic since December 29, 2001. He initially presented with left rib pain and underwent a series of treatments to help his complaint. Following that care, which he responded well to, he began a course of Wellness treatments to maximize his health. Mr. Jack, for as long as I have known him, has always taken a very active role in keeping himself in top physical condition.

After completing his Wellness Care in May 2003, I did not see this patient until July 2008. He reported that his exercise program and lifestyle had been keeping him in very good health. I saw Mr. Jack 4 times in 2008, twice in July and twice in August. Starting in March 2009, I saw Mr. Jack 31 times, 8 visits in spring 2009 and 23 visits over the span of September 22, 2009 to December 30, 2009. This time the treatments were for recurring complaints in a variety of locations. Since his complaints were not resolving as well as they had in the past, I continued to probe, trying to find the underlying aggravating factor. Mr. Jack reported that he was also concerned with the slow progress, and could only attribute it to an increase of stress at work.

During the course of treatment I discover that this stress was affecting his regular health routine. His sleeping, eating and exercise activities had changed, which did not help with his recovery. On January 21, 2010 Mr. Jack presented to my office reporting that he was feeling significantly better and had returned to his normal health routine. He told me that he had resigned from his job last month and that he was doing much better healthwise since. He asked me to write this letter to convey what had been going on with his health over the last year.

In conclusion, it was clear to me that towards the end of the year 2009 Mr. Jack's level of health had significantly decreased. He was affected to the point that he was not able to continue with his regularly healthy lifestyle. We were maintaining, but not making significant improvements with his presenting complaints, which he attributed to the stress at work. Now, after resigning from work, he reports that his health has returned and he has been able to return to his healthy lifestyle. If you have any further questions, please contact me.
