• The role of Staffing Advisor in Career Development Bureau Responsibilities include: providing specialized advice and guidance on staffing and other human resources issues. Works with other areas of the Human Resource Unit. Consult with Regional and Bureau staff, identifies approaiate staffing strategies, and administrators staffing activities, selection, redeployment and administrative transfers. Development and implementation sound selection methods and monitoring selection process while adhering to OPP and OPSS practices. Implement transfers and support position management. Additional assigned: Coordinator of the Probationary Constable Program for the Province. Responsibilities include lead facilitator on performance management at the Ontario Provincial Police Academy, administer, provide guidance, support and direction in relation to performance management with detachment members which include Coach Officers, Sergeants, Detachment Commanders and Regional Command Staff, Career Development Bureau Command Staff and Provincial Command.

# Coach Officer Responsibilities:

• Coach Officer's responsibilities associated with the daily coaching, development and supervision of a Probationary Constable. Coach Officers develops plan for training. Completes all performance evaluations in timely fashion and follows the submission schedule. These performance evaluations are forward to their accountable supervisor (Sergeant). Coach Officers provides feedback to the Probationary Constable and identifies deficiencies in the Probationary Constables performance evaluation. Coach Officer works with accountable supervisor and the Staffing Advisor from Career Development Bureau to create a Work Improvement Plan to address any deficiencies that have been identified. Coach Officer also recommends or not the Probationary Constable for permanency status. Mandatory requirement that coach officers attend revised coach course after the implementation of changes from the coach officer review project.

# Probationary period Probationary Constable In 2007

- Probationary Constable started pre training at Ontario Provincial Police Academy for one week.
- Probationary Constable attended Ontario Police College for 12 weeks
- Probationary Constables attended post training for 4 weeks.
- Probationary Constable arrive at detachment in month 5 of their one year probation period.
- Coach Officer would complete Monthly performance evaluations upon the arrival of the Probationary Constable at the detachment
- When Coach Officer identifies deficiencies a Work Improvement Plan would be initiated in efforts to correct the performance concern.
- To recommend a Probationary Constable, in Month 10 of their probation period he/she must meet in all categories and sub categories.

# In 2008 to Current

- Recruit Constables start pre training at Ontario Provincial Police Academy for one week.
- Recruit Constables attend Ontario Police College for 12 weeks.
- Recruit Constables attend post training at Ontario Provincial Police Academy for 5 weeks.
- Day of graduation, Probation period starts for one year from that date.
- Coach Officer would complete performance evaluations utilizing the following schedule. Month 1 and 2 Combined, Month 3, Month 4 Month 5, Month 6 and 7 combined, Month 8, 9 and 10 combined.
- When Coach Officer identifies deficiencies a Work Improvement Plan would be initiated in efforts to correct the performance concern and would revert to monthly evaluations until deficiencies have been addressed.
- To recommend a Probationary Constable in Month 10 of their probation period he/she must meet requirements in all categories and sub categories
